

Bosnia and Herzegovina solar energy proposal

How much heat energy will Bosnia and Herzegovina produce in 2020?

The planned trajectory for the heating and cooling sector in Bosnia and Herzegovina shows that production of heat energy from RES in 2020 would be 1085.2 ktoe, which represents an increase in production of renewable heat energy by 279.4 ktoe compared to the baseline year.

Should Bosnia and Herzegovina use more energy?

Bosnia and Herzegovina could do a lot more to use energy efficiently. Electricity prices are kept artificially low and there is therefore limited incentive to make savings. The country is almost four times as energy-intensive as the average in EU countries and has the highest energy intensity in the Western Balkans.

Which sector produces res energy in Bosnia and Herzegovina?

Production of RES energy in Bosnia and Herzegovina is dominated by the heating and cooling sector, for which an increase from the baseline 867.2 ktoe to 1085.2 ktoe in 2020 was planned. In addition, the share of electric energy sector in production of RES energy in the planned period increases from the baseline 444.2 ktoe to 760.6 ktoe in 2020.

Why should Bosnia and Herzegovina adopt the necp?

With the adoption of the NECP, Bosnia and Herzegovina should seek to improve the country's long-term resilience, advance its economic diversification and competitiveness, and to secure its energy supply and sovereignty by harvesting its natural renewable resources.

How much money has the EBRD invested in Bosnia & Herzegovina?

To date, the EBRD has invested more than EUR3.2 billion in 233 projects in Bosnia and Herzegovina. The Bank's strategic priorities in the country are to promote the green economy, support the development of the private sector and foster regional integration.

Bosnia and Herzegovina is a self-sufficient, net exporter of electricity. However, its energy sector relies mostly on fossil fuels, in addition to hydro and a negligible level of renewables. Bosnia and Herzegovina is well endowed with renewable energy resource potential; however, the sector is still in its initial stage of development.

sectors of Bosnia and Herzegovina. Recently, however, the country has seen some improvement in the amount of funding available for clean heating technologies, such as solar thermal, biomass boilers and heat pumps.

Bosnia and Herzegovina-based company Modul Energy plans to build a 8 MW solar power plant near Trebinje, an investment worth 10.9 million marka (\$5.9 million/5.6 million euro), the ministry of energy and mining of the Serb Republic said.

Bosnia's Serb Republic released a tender for granting a 50-year giving in contract for the building of an 80 MW solar energy plant worth an approximated 136.9 million marka (\$73.4 million/70 million euro), the entity's energy ministry stated on Wednesday.

The cost of this larger project was estimated at around 70 million euros. ERS is investing in renewable energy sources in an effort to diversify its energy portfolio. Besides Trebinje solar power plant, the company is developing a project for a 48 MW wind farm Hrgud in eastern Herzegovina, whose construction should start by the end of the year.

In 2012, Bosnia and Herzegovina established the first solar power plant (SPP) in the site called Kalesija. This solar power plant generates a power of 120 kWh and the panels are distributed over 1200 m². Converted solar energy is sent to the Electric Power Industry of B& H. Its annual production counts 150,000 kWh of electricity.

The European Bank for Reconstruction and Development (EBRD) is providing a EUR25.1 million loan to Elektroprivreda Bosne i Hercegovine (EPBiH), the largest public electricity generation and distribution utility in Bosnia and Herzegovina, to develop and construct a 50 MWp solar power plant on a former coal ash landfill site.

In December 2022, the Energy Community Ministerial Council adopted 2030 climate and energy targets. According to these, Bosnia and Herzegovina needs to achieve a 43.6 per cent share of renewables in gross final consumption of energy, and to reduce its greenhouse gas emissions by 41.2 per cent compared to 1990 levels - requiring a steady ...
