

How can Botswana improve its energy supply?

This includes increasing the supply and reliability of Botswana's energy supply, reducing the cost of domestic electricity, reducing and ideally removing the need for Botswana to import external energy and creating a revenue stream through the export of cleaner electricity and sale of gas. ..

How can Botswana contribute to decarbonisation?

Meeting Botswana's shortfall in electricity supply and contributing to decarbonisation. Creating a large Southern Africa energy/industrial hub suitable for manufacturing renewable energy and energy storage products, new-age materials, and products aligned with the resources sector.

Is Botswana listed on the Australian Stock Exchange?

It plans to utilise its huge, undeveloped CBM resources to become energy independent and create new industries.

Is hydrogen production a new high-tech industry in Botswana?

Hydrogen production would be an entirely new high-tech industry in Botswana. There are attractive commercial reasons to use CBM and atmospheric nitrogen to manufacture ammonia, urea and ultimately ammonium nitrate for use in fertilizer, explosives and as additive to diesel fuel.

How many shareholders does Botswana have?

It plans to utilise its huge, undeveloped CBM resources to become energy independent and create new industries. The directors and CEO collectively hold around 39% of the Ordinary Shares of Botswana. There are currently three substantial shareholders, each holding more than 5% of the ordinary shares of the Company.
