How are Turks and Caicos companies regulated?

Turks and Caicos companies are governed by the Companies Ordinance 2017 (as amended) and regulated by the Turks and Caicos Islands Financial Services Commission (FSC). There is no restriction on foreign ownership of shares of a company. Shares can be held by natural persons or corporate bodies.

Who are directors and officers of a Turks and Caicos registered company?

Directors and officers of a Turks and Caicos registered company can be either a natural person or a corporate body. The public (for a fee) can obtain a listing of directors and officers.

Why should you invest in Turks and Caicos?

There are several reasons to choose Turks and Caicos for offshore company formation. One of the primary reasons is safely investing in real property where having title in the name of a company separates it from other assets. Does Turks & Caicos impose a corporate income tax?

In the Turks and Caicos, there is no corporate income tax. However, businesses offering listed tourism services are required to charge and remit 12% Tourism Tax. Additionally, there is a telecommunication and insurance premium tax. The Companies Ordinance mandates that all companies must have a registered agent, who must be a licensed company manager.

Is a business license required in Turks & Caicos?

For corporations conducting business in the Turks and Caicos Islands, a business license is required. English is also the sole official language, contributing to the ease of managing your corporation in the Turks and Caicos.
