CALGARY, Alberta and HOUSTON, Texas, Jan. 24, 2022 (GLOBE NEWSWIRE) -- Enerflex Ltd. ("Enerflex" or the "Company") (TSX: EFX) and Exterran Corporation ("Exterran") (NYSE:EXTN) today announced a business combination (the "Transaction") to create a premier integrated global provider of energy infrastructure.

Is Exterran Corporation a publicly traded company?

Exterran Corporation was set up in 2007 and operated as a public company until it was acquired by Enerflex Ltd. on October 13, 2022. On Nov. 4, 2015, Exterran Corporation announced the completion of its previously announced spin-off from Exterran Corporation and emerged as an independent, publicly traded company.

What happens when Exterran and Enerflex combine?

The companies will combine in an all-share transaction pursuant to which Enerflex will acquire all of the outstanding common stock of Exterran. The company will operate as Enerflex Ltd. Cravath is representing Enerflex in connection with \$1.525 billion of committed bank and bridge financing for the transaction.

Who is Exterran's legal advisor?

King & Spalding LLP and McCarthy T&#233;rault LLP are acting as Exterran's legal advisor. Enerflex Ltd. is a single source supplier of natural gas compression, oil and gas processing, refrigeration systems, and electric power generation equipment - plus related engineering and mechanical service expertise.

What does the transaction value paid for Exterran mean?

The transaction value paid for Exterran implies an EV/2022E Adjusted EBITDA of 3.6x and Price/2022E Cash Flow of 1.9x, including synergies, respectively. Upon closing of the Transaction, Enerflex and Exterran shareholders will respectively own approximately 72.5% and 27.5% of the total Enerflex common shares outstanding.
