Are solar panels a good investment in France?

As electricity prices continue to soar in France - up 60% in four years - more people are turning towards solar panel kits, which promise to help users save on energy costs and installation prices. The estimated extra cost of electricity in 2024, compared to 2020, is EUR540 per household per year.

Does France have a solar market?

The French PV market is the fourth largest in Europewith 1GW installed each year. France has an objective to have a total of 20.6 GWp of solar installed by 2023, consistent with EU energy policies.

Which energy company has the biggest solar portfolio in France?

ENGIE a gas utility also present in the development and generation of electricity capacity - and has the biggest solar portfolio in France at around 1 GW (3 GW worldwide). Almost all local authorities have climate energy plans that are generally ambitious in terms of photovoltaic development.

Why is France launching a'solar registry'?

In addition, the Act established a 'solar registry' to help identify 'acceleration zones', listing the development potential of available roofs and carparks that could have solar panels added to them by local authorities. France is currently on course to miss its target to commission 20.1GW of solar power by late 2023.
