Is Ayala investing in Bataan solar?

Ayala-led AC Energy Philippines, Inc. (ACEN) is investing more funds into the development of a solar facility in Bataan. The power company told the stock exchange on Friday that it signed a subscription deal with its wholly owned subsidiary Bataan Solar Energy, Inc. (BSEI) to acquire P400 million-worth of shares.

### Why did AC Energy Invest in Bataan solar?

The investment in Bataan Solar is part of the company's P2.2-billion funding program to introduce new energy technologies in the Philippines. Last month, AC Energy also subscribed shares in Buendia Christiana Holdings Corp., one of its special-purpose vehicles, to buy and develop potential project sites.

### How GGGI & Bataan shared interest in solar PV development?

Based on the leadership level discussion between the two organizations, Provincial Government of Bataan shared their interest with GGGI to put up land as an equity for the development of up to 50 MW solar PV plant.

#### What does GGGI do in Bataan?

GGGI's intervention is to demonstrate the government interest in renewable energy transition, mobilize the in-country support from various national agencies, and shall attract private sector to engage with the market and submit concrete investment plans for solar PV deployment in Bataan. This project is aligned with IO2.

### What is Mariveles-Bataan solar power project?

Mariveles-Bataan Solar Power Project is a ground-mounted solar projectwhich is spread over an area of 37 hectares. The project generates 27,000MWh electricity and supplies enough clean energy to power 22,000 households, offsetting 15,532t of carbon dioxide emissions (CO2) a year. The project consists of 68,500 modules.

#### Did aceph get a green light for Bataan solar & Giga Ace 4?

ACEPH said in a disclosure that its board of directors had given the green lightfor the investments in Bataan Solar and Giga Ace 4, and had tasked a team to finalize the needed subscription agreements.

For the future solar power plant, Solen will finance, install and operate it. The company will sell its output to the Gabonese Water and Energy Company (SEEG) for 25 years under a power purchase agreement (PPA). In the long term, the Gabonese government aims to increase the share of renewable energy in its electricity mix to 80% by 2030.
