Maurel and Prom SA's \$730 million acquisition of Gabon-focused Assala Energy, owned by private equity fund Carlyle Group, was intended to strengthen the company's position in the country. Due to close between the fourth quarter 2023 and the first quarter of 2024, it is now likely to be delayed due to a military coup which occurred in Gabon on 30 August 2023.

London, UK - Carlyle-backed Assala Energy today announced the acquisition of Shell's onshore assets in Gabon, Africa, for \$587 million. Assala Energy will also assume associated liabilities, including a loan of \$285 million. Assala Energy is a portfolio company owned by global alternative asset manager The Carlyle Group (CG: NASDAQ).

Energy in Gabon comes from two main sources, fossil-fuels and hydroelectricity. Gabon also relies heavily on oil for its export revenues, exporting both crude oil and petroleum. In terms its oil reserves, the country is one of the richest in sub-Sharan Africa, ranking 5th after Nigeria, Angola, Sudan, South Sudan, and Uganda. Renewable energy in the form of solar power is virtually nonexistent.
