The valuation was based on the hourly output of a "composite" resource made up of nine distributed PV sample systems in Guam as described here. Micronesia Renewable Energy (MRE) provided hourly production data for 2015 for the nine systems, and the output of these are shown in Figure 1 on the peak system load day of the year, August 31, 2015.

A team from the National Renewable Energy Laboratory (NREL) visited Guam in August 2023 to assess failure modes of solar photovoltaic (PV) systems after Typhoon Mawar and to provide recommendations to increase the resilience of PV systems on Guam.
