Who is responsible for removing solar PV panels?

The costs of removing the Solar PV Panels and making good any damage on exercise of the break clause must be the responsibility of the Solar PV Panels provider. The building insurer must also be notified of the installation of the Solar PV Panels. The minimum CML requirements must be met.

What are the UK Finance requirements for solar PV panels?

The minimum UK Finance requirements must be met. In addition, the lease must provide a valid mortgagee break clause which can be exercised on possession.
