What is the difference between a small enterprise and a medium-sized enterprise?

small enterprise: fewer than 50 employees and an annual turnover or balance sheet below EUR10 million.
medium-sized enterprise: fewer than 250 employees and annual turnover below EUR50 million or balance sheet below EUR43 million. fewer requirements or reduced costs when complying with EU legislation.

What are small and medium-sized enterprises?

Small and medium-sized enterprises (SMEs) -- in other words, enterprises with fewer than 250 persons employed-- are often referred to as the backbone of the European economy, providing jobs and growth opportunities.

How do economists classify small and medium businesses?

Small and medium enterprises are named by adjectives indicating size, thus economists tend to divide them into classes according to some quantitative measurable indicators. The most common criterion to distinguish between large and small businesses is the number of employees (Hatten: 2011).
