The Isle of Man has two separate but co-existing company law regimes: The Companies Acts 1931-2004 (collectively referred to as the 1931 Act) and the Companies Act 2006 (the 2006 Act). We refer to all such companies in this guide as Manx Companies.

2 Compulsory Online Filing of Company Income Tax Returns . Under Isle of Man law, corporate taxpayers are legally required to file their tax returns for accounting periods ending on or after 5 April 2015 online, using the Isle of Man Government's Online Services.

Trading losses and excess capital allowances may be surrendered (subject to certain restrictions) between 75% affiliates resident in the Isle of Man. Similar concessions are available to members of a consortium, but only a fraction of the loss or excess may be set-off, that fraction being equal to the members" share in the consortium in the relevant year of assessment.
