When is the next CRE PV tender?

CRE will hold the next tender on Nov. 20,2023,with a volume of 925 MW. Last April,the French government announced the launch of a tender for 1.5 GW of ground-mounted PV and another tender for 800 MW of rooftop capacity,in order to compensate for the high failure rate of the third round of tenders for large-scale PV plants.

How much does a PV project cost?

The tender was open to PV projects ranging in size from 500 kW to 5 MW. The minimum carbon footprint was set at 200 kg CO2 eq/kW and the maximum at 550 kg CO2 eq/kW. The commissioning time was increased from 24--30 months. The procurement exercise concluded with an average price of EUR0.0824 (\$0.0868) per kWh.
