Who is developing Morocco's largest wind power facility?

For example, Morocco's largest wind power facility is being developed by Total Eren, a wholly owned subsidiary of French energy giant Total Energies, 10 as part of the company's \$10 billion green ammonia mega-project in Morocco's Guelmim-Oued Nour region.

### What is Morocco's energy strategy?

Morocco's chief focus is its large-scale solar and wind strategy, which is underpinned by strong political will. In 2008, the government developed a renewable energy and energy efficiency plan, which set a goal to reach 42% renewable energy generation capacity (not consumption) by 2020. (Consumption will be lower because of intermittency.)

## Is Morocco an energy-wealthy country?

In 2010,Law 13-09 allowed independent wind and hydroelectric power producers to sell power to the utility company and allowed for renewable energy export. Consistent with the critical geopolitics lens,the Moroccan government is reframing Morocco as an energy-wealthy country,awash with renewable energy resources (Fig. 5.2).

## Does Morocco's green energy system contribute to high-quality job creation?

The production of and transition to renewable energy through Morocco's green energy system is emerging as a key contributor to high-quality job creation. The expansion of the green industrial manufacturing and sustainable solutions sectors is at the threshold of becoming a driver for more expansive high-quality job creation.

#### What is Morocco's green energy ecosystem?

Within Morocco's green energy ecosystem, climate-smart and green technologies are emerging as a foundation of its innovation ecosystem fstart-up MSMEs and the incubators and accelerators to support them.
