

# Minimum living allowance can apply for solar power generation

Current rules that require businesses to apply for planning permission if solar panels will generate more than one megawatt of electricity will also be scrapped, meaning organisations will be able to install more solar panels on rooftops without the delay and cost of applying for planning permission.

How much land does a solar farm need?

Generally, a solar farm requires around 25 acres of land for every 5 megawatts of installation capacity. Not all of this land will be usable for a project. So, developers tend to seek around 200 acres for a commercial-scale project to be on the safe side. A minimum of 10 acres is considered the industry standard for smaller projects (around 1MW).
