#### Who owns Mozambique Rovuma venture area 4?

About Mozambique Rovuma Venture Area 4 is operated by Mozambique Rovuma Venture S.p.A. (MRV), an incorporated joint venture owned by Eni,ExxonMobil and CNPC, which holds a 70 percent interest in the Area 4 exploration and production concession contract.

#### Who are the sponsors of FID in Mozambique?

Additional sponsors include ENH Rovuma Área Um, S.A, Mitsui E&P Mozambique Area1 Ltd., ONGC Videsh Ltd., Beas Rovuma Energy Mozambique Limited, BPRL Ventures Mozambique B.V., and PTTEP Mozambique Area 1 Limited. The contract award will be reflected in McDermott's backlog once Anadarko approves FID, which is expected in June 2019.
