

What is North Macedonia's Energy Development Strategy?

North Macedonia's draft Energy Development Strategy until 2040 is the first to comply with the rules of national energy and climate plans in the Energy Community, the Energy Community Secretariat said following the draft's presentation. The document is also in line with the five dimensions of the EU Energy Union.

What is North Macedonia's just energy transition investment platform?

North Macedonia today launched a just energy transition investment platform to guide its far-reaching plans for a low-carbon and just transition of the electricity sector.

Should North Macedonia accelerate the transition to renewables?

Like others in the region, North Macedonia must balance its need to rapidly accelerate the transition to renewables to secure its energy future with the need to ensure that future is one where both the country's nature and people thrive.

Is North Macedonia a state-owned power company?

North Macedonia's state-owned power company was unbundled and partially privatized in the early 2000s. Austrian utility company EVN has been responsible for electricity distribution in North Macedonia since entering the market in 2006.

Did North Macedonia change its energy regulations?

There were no major energy legislative changes, but North Macedonia continued to harmonize its energy regulations with the EU Energy Community's Third Energy Package (TEP). North Macedonia's state-owned power company was unbundled and partially privatized in the early 2000s.

Does North Macedonia need a coal phase-out?

Even though the country has historically been dependent on lignite coal mining for around 30% and gas imports for an additional 15% of its electricity production, it has nonetheless set very ambitious goals for decarbonization. As part of the Powering Past Coal Alliance, North Macedonia has committed to a coal phase-out by 2027.

The idea is for ADEX to be a one-stop shop for clients, he said and asserted it was agreed it would provide services to power exchanges in Montenegro and North Macedonia.
