In coordination with the Ministry of National Assets, the programme aims to allocate energy storage capacity across four regions - Arica and Parinacota, Tarapaca, Antofagasta and Atacama.

The Commonwealth of the Northern Mariana Islands (CNMI) meets nearly all of its energy needs with imported petroleum products. In 2021, refined petroleum products were CNMI's top import and accounted for 18% of the Commonwealth's total import costs that year.

The project will be located on the island of Eday, Orkney, off the northern coast of Scotland, at the European Marine Energy Centre's (EMEC) tidal energy test site, with a 1.8MWh flow battery from Invinity Energy Systems installed to help "smooth" tidal generation.
