Did a high-ranking Chinese solar panel executive commit a white-collar crime?

A high-ranking executive of a Chinese solar panel maker was arrested on arrival at Munich airport in Germany accused of white-collar crimedating back several years to now-defunct EU trade measures against the Asian giant.

Are Chinese detainees forced to produce solar panels?

In state-sponsored programmes, detainees are forced to produce goodsincluding polysilicon, a core ingredient in solar panels, according to the US Department of Labor. The Chinese government has always staunchly denied all allegations of human rights abuses in Xinjiang.

What happened to Chinese photovoltaic executives at Intersolar Europe?

Some industry insiders said the sudden development reminded them of an incident that happened in 2019, when a number of senior executives of Chinese photovoltaic companies were reportedly taken awayby German authorities during the Intersolar Europe exhibition, which sent shockwaves across the industry at that time.

What happened to solar Fabrik?

After setting up ESC Verwaltungs GmbH in 2010, Laibacher served as managing director and applied for its liquidation in 2022. In summer 2016, Laibacher acquired part of Solar Fabrik's production operations after it filed for bankruptcy. He then founded Solar Fabrik CL GmbH and moved production from Freiburg to Aschaffenburg.
