

Can a business company be incorporated in St Vincent and the Grenadines?

Business Companies Business Companies (formerly international business companies) can be incorporated in St. Vincent and the Grenadines for the conduct of legitimate or legal business activities. The application for the incorporation of a Business Company must be made through a St. Vincent and the Grenadines licensed Registered Agent.
