What is Senegal's energy policy?

The IEA's Energy Policy Review of Senegal 2023, published today, finds that energy is at the heart of Senegal's 2035 strategy for accelerating sustainable development and economic growth known as the Plan Sénégal 2035, or the Emerging Senegal Plan.

Who produces energy in Senegal?

Energy is produced by private operators and sold to the Senelec energy corporation. According to a 2020 report by the International Energy Agency, Senegal had nearly 70% of the country connected to the national grid. Current government strategies for electrification include investments in off-grid solar and connection to the grid.

How much energy does Senegal have?
