What was the EU export value of solar panels in 2023?

The EU import values of solar panels and liquid biofuels in 2023 were much higher than the corresponding EU export values which were EUR0.9 billionfor solar panels and EUR2.2 billion for liquid biofuels. By contrast,the EU export value of wind turbines in 2023 (EUR2.0 billion) was much higher than the corresponding value for imports.

Which countries import solar panels?

o Note: Europe figure includes EU,Norway,Switzerland,Serbia,North Macedonia and Kosovo. Both the EU and the USare heavily reliant on imports to meet solar PV demand,each running a trade deficit for solar PV modules and cells of about \$20 billion in 2023 (Figure 6).

Which countries import solar cells to the EU?

In 2022 and 2023,imports of solar cells to the EU were almost exclusively from China. In 2024 to date, China's share of solar cells imported to the EU has fallen by around 20 percent. Over the same period the value of solar cells imported into the EU has dropped significantly (Figure 8a).
