How can Surp II help Somalia?

UN agencies, INGOs and donor groups in Somalia supporting the government with similar projects on service delivery as well as economic and infrastructure development. How much does the Somalia Urban Resilience project cost?

The Somalia Urban Resilience Project (SURP) II has a project budget of US\$112 million (US\$62 million from the Multi-Partner Fund Somalia and US\$50 million from the International Development Association, IDA). Four cities have been selected for urban regeneration and renewal.

How many properties are affected by the Somali water crisis?

1 There are total of 25 project affected properties, including two rooms, four kitchen, five fence walls, two "berkeds" (traditional Somali water storage cisterns), five temporary kiosks, five pit latrines, and two septic tanks. The main mitigation measure proposed is compensation for the affected properties.
