Today, the Government of Trinidad and Tobago has officially given the green light to project partners, bp, Shell and Lightsource bp to begin construction of the largest solar project in the Caribbean.

Who owns 148mw solar project in Trinidad & Tobago?

The Government of the Republic of Trinidad and Tobago (GoRTT) has approved the consortium partners 148MW solar project. The consortium have reached the Final Investment Decision, with bp and Shell initially having joint shareholdings of the project (50/50).
