What is open solar contracts?

As a response, the International Renewable Energy Agency (IRENA) and Terawatt Initiative (TWI) undertook a joint efort to simplify and streamline the contractual framework for solar power. The Open Solar Contracts initiative aims to unlock greater investments globally.

Renewable power purchase agreements (PPAs) - direct contracts between corporate companies and electricity suppliers- are expected to become a major driver for more market-based renewables deployment in the coming years. However, the take-up of this concept has been much slower than expected.

When will the European Solar charter be implemented?

One year following the signature of the Charter, the Commission will review the implementation of the adopted commitments. The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.

What is a PV installation agreement?

The Installation Agreement is a lump-sum agreement between the project company, as owner of the project, and the installation contractor, the contractor that will be responsible for installing the PV system, providing the balance of plant and commissioning the plant.
