Who makes the most solar panels in the world?

Tongwei Solar is the world's largest solar panel manufacturer; it shipped 38.2 GW of solar cells and solar panels in 2022. That's the equivalent of over 100,000 typical 350 watt (W) solar panels. On top of that, Tongwei Solar has an annual solar cell production capacity of 70 GW, and an annual solar panel production capacity of 14 GW.

What are the top solar panel manufacturers?

The top global solar panel manufacturers, based on their scale, include companies such as TW-Solar, JA Solar, AIKO, and others - these manufacturers ship a large number of solar products around the world each year.

How has global solar PV manufacturing capacity changed over the last decade?

Global solar PV manufacturing capacity has increasingly moved from Europe, Japan and the United States to China over the last decade. China has invested over USD 50 billion in new PV supply capacity - ten times more than Europe - and created more than 300 000 manufacturing jobs across the solar PV value chain since 2011.

What are China's solar PV exports?

In 2021, the value of China's solar PV exports was over USD 30 billion, almost 7% of China's trade surplus over the last five years. In addition, Chinese investments in Malaysia and Viet Nam also made these countries major exporters of PV products, accounting for around 10% and 5% respectively of their trade surpluses since 2017.

Where are solar panels made?

With its headquarters in China, TW-Solar is renowned as the largest polycrystalline silicon producer and for its extensive production capacity at 80GWp per year. There are a few solar panel companies in the UK, including England-based UKSOL, GB-Sol in South Wales, and Viridian Solar (who produce roof-integrated solar panels).

Which country exports the most solar panels?

In 2021, the United Kingdom accounted for the largest share of solar panels exported from the European Union, with roughly 23 percent of extra-EU exports.
